Started in 2012, this program has been presented in over 70 countries with proven results.

The Foundation also supplied hlep for victims of the 7.2 earthquake in Haiti and a Category 2 cyclone in Fiji, and continued to support the development of seed banks in Ecuador

Three FFP facilities are in operation: on in India, one in Nepal and one in Ghana. All three continue to be attuned to the communities they server, offering additional support as possible.
